The District anticipates making award on the basis of a primary (low bid) and a secondary (next lowest bid) service provider(s). The primary service provider shall be utilized first. If the primary service provider is not able to respond and/or complete an order within specified requirements, the secondary service provider shall be utilized. Should the secondary service provider be unable to respond and/or complete a purchase within the necessary timeframe, the district reserves the right to acquire the goods specified herein from any other source or via any other procurement method deemed by the School Board of Okaloosa County to be in its best interest. The Board reserves the right to waive any informality, to make mathematical correction to error/s in any bid, waive any minor irregularity or technicality in bids received or to reject all bids and re-advertise, with either the identical or revised specifications. Per the terms and conditions of the bid, the Committee would like to delete Item 2 (5 Feet High Chain Link Fence and Gate - 2a thru 2m) and Item 5 (10 Feet High Chain Link Fence and Gate 5a thru 5o) from this bid. Consideration of the items to be deleted from this bid are in the best interest of the School District of Okaloosa County and have not been contracted items for the past several years. This Contract is for a three (3) year period commencing on or around July 14, 2015. The normal ending date for this contract shall be July 13, 2018.
