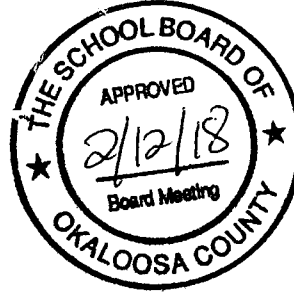

Committee Recommendation:
Committee recommends award to the lowest responsible and responsive bidder Cox Communications Gulf Coast in the amount of \$38,700.00 (based on a 12 month contract period before E-Rate is applied). The Committee recommends a 1Gbps and 5 Gbps award for the Central Administrative Complex in Niceville. Additional sites are not awarded at this time but may be in the future to the recommended bidder. Future bandwidth upgrades will be priced as stated as long as the contract is in force. The initial contract term is one year with the option for up to four additional years at the same terms and conditions. Services agreed upon above shall begin on July 1st, 2018.
