Mr. Hodges,

On August 13, 2018, the School Board of Okaloosa County, Florida approved the award of ITB 18-22 Services to Inventory Capitalized Property with your organization. The original contract term was for the period of August 18, 2018 through June 30, 2023.

Bid terms state that the contract term of this bid, upon mutual agreement of the parties, may be extended for an additional five-year term. We would like to request that this bid be extended for the period of July 1, 2023 through June 30, 2028.

The School Board of Okaloosa County approved an increase for recording property on October 24, 2022. The limit for property went from \$1,000 per item to \$5,000 per item. This threshold increase has reduced the number of items in our inventory to approximately 1,540 items. Due to the reduced number of items, we have negotiated a revised price of \$13,000 annually. The cost for the change of Custodians is to remain the same at \$30 per hour.
