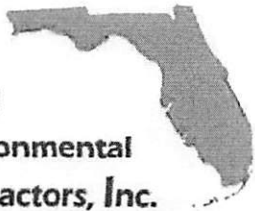

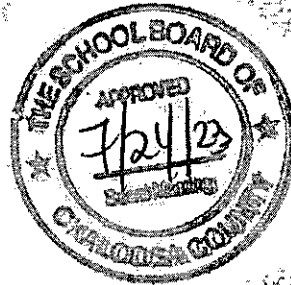

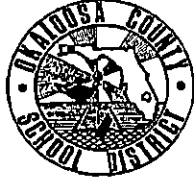

Mr. Chambers,

The Maintenance Department received a cancellation notice letter from the awarded vendor, T&N Lawn Masters, LLC on July 17, 2023 stating that they can no longer effectively provide the District with the appropriate lawn care services that are expected and outlined in our current contract. A copy of the cancellation notice letter is attached.

This contract is for a three (3) year period, July 1, 2023 through June 30, 2026 and was School Board approved on May 22, 2023.

After discussion with Steve Bolton, concerning this contract, it is my recommendation that this contract be terminated for cause due to the default of the Contractor effective July 17, 2023. Upon cancellation payment will be made to T&N Lawn Masters, LLC for services that have been satisfactorily rendered prior to the effective date of termination. It is also my recommendation to remove this vendor from the District's bid list for the duration of one (1) year per School Board Policy 2-17(A)(10)(c). The firm may apply for reinstatement to the list after being removed for one year after provision of evidence satisfactory to the Superintendent or School Board that causes have been remedied.

The Purchasing Department will submit a request for approval to the School Board on the July 24, 2023 agenda to award the remaining contract to the next lowest responsive and responsible bidder, Gulf Coast Environmental Contractors, Inc., effective July 25, 2023.

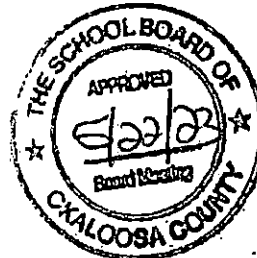

**AGREEMENT BETWEEN THE SCHOOL BOARD  
OF OKALOOSA COUNTY, FLORIDA  
AND GULF COAST ENVIRONMENTAL CONTRACTORS, INC.**

**THIS AGREEMENT** is made and entered into effective July 25, 2023 (the "Effective Date"), and is by and between The School Board of Okaloosa County, Florida, operating a district school system in the State of Florida (the "District"), and Gulf Coast Environmental Contractors, Inc., a corporation authorized to transact business in Florida (the "Contractor").

**WITNESSETH:**

**WHEREAS**, the District issued ITB 23-06 dated on or about March 28, 2023, relating to the Lawn Care Services for Multiple Schools for the Okaloosa County School District, together with Addendum No. 1 dated April 12, 2023, (collectively, the "ITB"), a copy of which ITB is attached hereto and incorporated herein by this reference as Exhibit A;

**WHEREAS**, after free and open advertised solicitation, Contractor submitted a bid proposal attached hereto and incorporated herein by this reference as Exhibit B (the "Proposal");

**WHEREAS**, the Contractor is interested in and capable of performing the desired Lawn Care services (hereafter further defined as the "Services") for the District and the District desires to have the Contractor perform the Services; and

**WHEREAS**, the parties have reached an agreement on the Services to be performed and the payment for the same, and therefore wish to set forth this understanding in writing in this Agreement.

**NOW, THEREFORE**, in consideration of the mutual covenants and conditions contained herein, the parties agree as follows:

**ARTICLE I  
SCOPE OF SERVICES**

1.1 The recitals set forth above are true and correct and are incorporated into this Agreement by this reference.


1.2 The parties agree that the purpose of this Agreement is that the Contractor shall fully, timely, and continuously provide the District the Services in a manner in accordance with the District's objectives set forth in the ITB and this Agreement. 
