

Ranking Points:

At the RFQU Evaluation Committee Meeting, each member ranks the firms based on the points received on the committee member's individual score sheet for each firm. The firm ranked as number one receives three (3) points. The firm ranked as number two receives two (2) points. The individual ranking points of each of the RFQU Evaluation Committee members are added together to produce a total ranking points score for each firm. The firm with the highest total ranking points score is ranked number one.

Committee Recommendation:

The Evaluation Committee for RFQU 19-01 Construction Total Program Management (TPM) Services met in public session on 9/26/18.
