<u>Title</u>

C39 Request Permission to Renew Bid 3538AH - Food Service, Large Equipment

Action Rationale and Results

The Food & Nutrition Services Department requests permission to renew Bid 3538AH which provides a percentage-off discount on large cafeteria equipment for use in all food service areas throughout the District. The supporting vendors have agreed to renew this bid for an additional year using the same discounts, terms and conditions established in 2015.

Methodology, Cost and Timeframe

The supporting vendors are: Designs, Furnishings & Equipment of Daytona Beach, Florida and International Restaurant Distributors of Apopka, Florida. The resources required for this renewal are \$2,000,000. The term of this renewal is from June 1, 2016 to May 31, 2017.

Effect of Action

With this renewal, the Food & Nutrition Services Department will be able to continue to appropriately equip school cafeterias throughout the District to serve students appealing and nutritious meals with the purchase of the new or replacement equipment for cafeterias using established discount pricing.
