

Definitions for abbreviation/acronyms listed on tabulation sheet:

DF Lbs per Case –United States Department of Agriculture (USDA) Donated Food

FFS per Case - Fee For Service – Under this arrangement, the end or processed products are sold for a processing fee, which represents the processor's (manufacturer's) costs for labor, packaging, other ingredients, and administrative overhead. With Fee For Service, the value of the USDA donated food (commodities) in the end products is not included on the invoice from the processor (manufacturer). The product is delivered to and stored at the State contracted USDA warehouse. We own the product and order as needed.

NOI per Case - Net Off Invoice – Under this arrangement, the district informs manufacturers of its chosen distributor, which for this district would be our current awarded food and supply distributor, Gordon Food (GFS). GFS owns and supplies the district with manufacturers' product which is order as needed. Once delivered to the schools, the district is invoiced the commercial price minus the USDA donated food (commodities) value by the commercial distributor (GFS).

Background information:

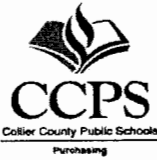
Proposals were submitted along with samples of products that were proposed as alternates to what was specified. Our staff Registered Dietitian evaluated nutritional information, ingredients, USDA meal components and pack size to determine whether the alternates were equal to the specified product. A taste panel taste tested the approved alternate products to assist in making recommendations for award.

Items #6 Beef Taco Filling, #17 Whole Grain Macaroni & Cheese, #26 3-Meat Italian Style Sandwich and #50 Fully Cooked Diced Pork are intentionally omitted as no acceptable product was submitted.

The criteria for items that are recommended for award are based on a variety of components: ingredients, compliance with USDA meal components, nutritional value, pack size, taste acceptance and price.
