Intent	The intent of this bid is to award a contract to multiple vendors that offer a discount off the Manufacturer's Published Price List(s) for the purchase and delivery of Large Kitchen Equipment.
Recommendation	Awards for all line items are noted on the attached tabulation sheet. Several factors were used to determine the awards. The bid document stated that discount ranges would not be accepted, so bids for any line items where vendors included ranges were disqualified. Florida Statute 287.084 establishes a preference for Florida businesses, which also impacted awards for some line items. Finally, a tiebreaker was needed for some line items, so the "Toss of a Coin" was used to determine the award.

All other offers submitted in response to this solicitation, if any, are hereby rejected as late.
