SUBJECT:

Pre-Kindergarten, Adult Vocational and Occupational Therapists Supply Stipend

The School Board at the September 25, 2006, School Board Meeting, approved to pay a stipend of \$267.00 per teacher to certified Pre-Kindergarten, Adult Vocational teachers, and Occupational Therapists for materials and supplies. Attached please find your school's Pre-Kindergarten, Adult Vocational teachers, and Occupational Therapists' check and a spreadsheet reflecting eligible positions.

The requirements for these funds will be the same as the Florida Teachers Lead Program. The requirements are as follows:

- 1. In accepting a check, the teacher is required to sign an agreement form accepting these funds (see attachment). The teacher agrees to keep all receipts and to spend the funds for the sole purpose of purchasing classroom materials and supplies to be used in the instruction of students assigned to them. The teacher also agrees to return any unused funds to the school at the end of the school year.
- 2. The attached check will need to be deposited into your school's Internal Funds bank account. The deposit should then be entered into the Manatee Accounting System and coded to account number 9 800. The bookkeeper should then process a check to each individual teacher on the attached list.
- 3. If there are any teachers at your school who do not spend all of their funds, those dollars should be remitted to the School District on a MIS 3218 Cash Transmittal Form prior to the end of the school year. Please note on the transmittal form that the returned money is from Pre-K, Adult Vocational teachers or Occupational Therapists.
