Summer Intensive Studies (SIS) Reading and Math - Project 6127

The Finance Department has received the attendance numbers from last year's Summer Intensive Studies (SIS) from Information Systems to budget for Fiscal Year 2006-2007 SIS allocation. The attached spreadsheet reflects your school's allocation based on a teacher – student ratio of 15:1.

### Additional SIS Information:

- 1. Your school's allocation has been budgeted in 1010-5100-0510-you cost center-6127. Your school can begin making budget amendments to allocate dollars to the specific expenditure objects required to implement your summer program.
- 2. Just as last year, there will be two attendance recapture dates. The first one will be in June 2007. Schools experiencing a growth in attendance will receive a corresponding increase in their allocation. The second attendance recapture date will be in July for those schools continuing SIS.
- 3. The District will continue the "Hold Harmless" policy subject to available funding. Last year schools which experienced a decrease in attendance after the initial and subsequent allocations did not experience a corresponding budget reduction. This policy will continue as long as there are available SAI dollars. But please keep in mind, if SAI funding becomes limited, there is a potential that funds may have to be pulled back for declining attendance based on the attendance capture dates.
- 4. Your school's SIS allocation does <u>not</u> include transportation costs. Transportation costs will be handled at the District level. The Transportation Department will calculate the cost per school and send it to Finance. Finance will charge the expenditure out to the school level and allocate the corresponding budget amount. Therefore, schools will not pay for transportation costs from their SIS allocation. *Transportation costs will be above and beyond your school's SIS allocation.*
- 5. <u>NEW</u> For fiscal year 2006-2007, Middle Schools will receive an additional allocation based on middle school students retained due to two or more core course failures. By May 25<sup>th</sup> please send the number of students that qualify for SIS to Finance. Once Information Systems verifies your student data, we will allocate additional funds.
