SUBJECT: Distribution of Budgetary and Internal Funds for Consolidated Centers

Effective fiscal year 2007-2008, Crestview Vocational School, North Okaloosa Institute, and Crestview High School are consolidated. Pre-Kindergarten through fourth grade students who would have attended Oak Hill Elementary will now attend Cherokee Elementary. Students who would have attended fifth grade at Oak Hill Elementary and Cherokee Elementary will attend Lewis Middle School. The distribution of budgetary and internal funds related to the consolidation are as follows:

I. Crestview High (0601), Crestview Vocational School (0602), and North Okaloosa Institute (0604)

Budgetary Funds - 100% of the budgetary carryover funds for Crestview Vocational and North Okaloosa Institute have been transferred to Crestview High School. (North Okaloosa Institute had zero balances in all available budgets; therefore, no funds were transferred.)

Internal Funds - 100% of the Internal funds at Crestview Vocational School will be transferred to Crestview High School. (North Okaloosa Institute does not have Internal funds.) These funds must be placed in accounts that represent their original purposes. Once all funds have been transferred to Crestview High School and all outstanding checks have cleared, the Director - CHOICE will seek School Board permission to close the Crestview Vocational School checking account. Once approval is granted, the account must be closed.

II. Lewis Middle (0671), Cherokee Elementary (0161), and Oak Hill Elementary (0441)

Budgetary Funds - Budgetary carryover funds remaining at the end of fiscal year 2006-2007 have been distributed based on the Final Fiscal Year 2006-2007 UFTE Count. The available carryover funds for Cherokee Elementary and Oak Hill Elementary were added together to obtain the <u>Total Elementary Carryover</u> funds. This amount was divided by the <u>Total Elementary UFTE</u> (unweighted FTE) to obtain the amount of carryover available per UFTE for discretionary and each project budget. Funds for 100 fifth grade students were transferred to Lewis Middle, and the remaining funds were budgeted at Cherokee Elementary. The following projects will remain entirely at the elementary level: Donation – Other (4009), Lottery – School Recognition (7160), School Maintenance Project (2909), Summer Intensive Studies – SAI Project (6127), and Title I Project (7401).

Internal Funds – Cherokee Elementary and Oak Hill Elementary have transferred fifth grade account funds to Lewis Middle. Lewis will also receive a distribution of the general/discretionary internal funds from Cherokee and Oak Hill Elementary using the same methodology applied to budgetary funds. Oak Hill Elementary's remaining funds will then be transferred to Cherokee Elementary. Once funds are distributed from Oak Hill Elementary's checking and SBA accounts and all outstanding checks are cleared, Cherokee Elementary School will seek School Board permission to close Oak Hill Elementary's checking account. Once approval is granted, the account must be closed.

NOTES:

- 1. Beginning in FY 2007-2008, Oak Hill Elementary will be consolidated into Cherokee Elementary. Students in pre-kindergarten through 4th grade will attend Cherokee Elementary. Students in 5th grade will attend Lewis Middle. Carryover funds are being distributed accordingly.
- 2. The available carryover funds for Cherokee and Oak Hill Elementary were added to create a Total Elementary Carryover.
- 3. The Total Elementary Carryover was then divided by the Total Elementary UFTE to obtain the amount available per unweighted FTE. (Example \$613,574.92 / 835.27 = \$734.58)
- 4. Lewis Middle will receive funds based on an estimated 100 students which transferred to Lewis. The remaining funds will be transferred to Cherokee Elementary.
- 5. Calculation of UFTE:
