Middle School Math Tutoring

SAI - Secondary Math Remediation - Project 9161

In order to increase enrollment in advanced math classes and support students in mastering necessary math skills, middle schools will be provided the necessary funds for offering tutoring to math students in need of assistance and to those students who fall below FCAT proficiency. The attached spreadsheet reflects each school's allocation.

Pertinent information regarding your school's math tutoring budget is as follows:

- Your school's allocation has been budgeted in salaries for Other Compensation (1010-5100-0102-Center-9161). Available funds will be pulled back at the end of this fiscal year.
- A total of eight hours per week (two hours of tutoring per day) will be funded for 12 weeks (4 weeks in Quarter 2 and 8 weeks in Quarter 3). Quarter 4 will be funded based on tutoring needs determined by Quality Assurance.
- All tutoring must occur before or after school, outside of the teacher's regular-duty day on Monday through Thursday.
- Math tutoring will be offered at each middle school for the following purposes:
 - Remediation of core content in all math classes
 - Remediation for FCAT: students scoring below proficiency
 - Completion of homework and/or missed assignments
 - Review for tests
 - Remediation due to test/quiz failure
 - Review of math concepts
- A roster must be kept with student names, dates of tutoring, length of session and teacher's name. Students should sign in daily and stay for the entire session.
- If no students show up on a given day, the teacher will not be compensated for the time.
- It is the school's responsibility to advertise the program to parents.
- It is the classroom-math teacher's responsibility to contact parents and schedule students into
- The expected ratio is 15 to 1; if attendance consistently falls below that ratio, adjustments may need to be made in the number of teachers providing tutoring services.
