CSR - FAIR Assessment - Project 0113 - Second Allocation

On August 27, 2009, the District provided financial assistance to help elementary and K-12 schools provide a half-day substitute for each Kindergarten, 1st, and 2nd grade teacher administering the FAIR assessment to individual students.

The District is now providing an allocation to fund a whole-day substitute for the Kindergarten, 1st, and 2nd grade teachers administering the second round of FAIR assessments. Each school was asked to provide the number of teachers in these grade levels, and funds have been allocated to CSR - FAIR Assessment (Project 0113). Any additional time required will be the responsibility of the school.

The attached spreadsheet reflects the number of Kindergarten, 1st, and 2nd grade teachers at each school and their corresponding allocations. As you know, the instructional substitute rate of pay is \$64.86 or \$89.18 per day, depending on degree; therefore, Budgeting has allocated \$89 per teacher plus corresponding benefits. When entering substitute information into the payroll system, please enter the following budget strip: 1010.5100.0750.Center.0113. If the substitutes have already been paid from other budgeted funds, please submit a Transfer of Expenditure to charge Project 0113, noting that the substitutes were for FAIR testing.
