**Custodial Privatization Contract** 

The fiscal year 2010-2011 Custodial Privatization Contract was approved by the School Board on August 9, 2010. Twelve schools have chosen to participate in the custodial service program.

The attached spreadsheet indicates the following information:

- Purchased Positions (Columns A L) These columns show the number of full-time equivalent (FTE) District positions purchased by the schools as of August 17, 2010, and their corresponding Salary Menu costs.
- Purchased Equivalent Hours (Column M) This is the number of District FTE positions multiplied by 7.50 hours per day. This number has been calculated to compare to the number of school hours (District positions) required per the contract.
- School Hours Per Contract (Column N) These are the number of hours (District positions) that a school is required to purchase based on the GCA contract.
- Schools Hours Over/(Under) (Column O) This indicates the difference between hours purchased by schools and hours required by contract for District positions. If there is a positive number in this column and the school has a custodial vacancy, the school may cash in that number of hours.
- GCA Contract Costs (Column P) This is the contract cost that the school must pay to GCA.

Each school's budget for the GCA contract cost has been moved from 1010.7900.0310.Center to 1010.7900.0310.Center.0012. This may have caused a negative budget for some schools that had not originally budgeted for the custodial contract. Please make sure this deficit is cleared no later than August 21, 2010. The custodial service contract will be expended from Custodial Privatization (GCA) – Project 0012. In addition, the budget and expenditures for all custodial positions at the participating schools have been moved to Custodial Privatization (GCA) – Project 0012.
