SUBJECT: AICE, AP, and IB Recalculation

The District initially calculated allocations for Advanced International Certificate of Education (AICE – Projects 9004 and 1004), Advanced Placement (AP – Projects 2154 and 7054), and International Baccalaureate (IB – Project 7055) using WFTE earned as a result of the 2010-2011 AICE, AP, and IB student scores and/or diplomas.

On October 18, 2012, Information Systems provided the 2011-2012 AICE, AP, and IB student scores and/or diplomas. Finance has recalculated the allocations based on this information. Attached are the following spreadsheets:
