SUBJECT:

Career and Professional Education (CAPE) Institutes - New Projects

Per Florida Statute 1011.62(o)(2), each district must allocate at least 80 percent of the funds provided for CAPE industry certification to the program that generated the funds. Our District has allocated 90 percent of all CAPE funding to CAPE – Project 9007, and the schools have been responsible for making sure that the funds were expended for the appropriate program/institute. In order to ease this process, we have set up new CAPE projects as shown below:

- CAPE Aerospace/Aviation Project 5061
- CAPE Automotive Project 5072
- CAPE Child Development Project 5062
- CAPE Construction Project 5063
- CAPE Culinary Project 5064
- CAPE Drafting/Engineering Project 5065
- CAPE Electrical Project 5066
- CAPE Health Science Project 5067
- CAPE Information Technology Project 5068
- CAPE Robotics Project 5069
- CAPE Veterinarian Technology Project 5070
- CAPE Welding Project 5071

The Career & Technical Education Department worked with the schools to determine the proper distribution of the funds remaining in CAPE – Project 9007 as of December 1, 2014. The Budgeting Department has re-appropriated the <u>available</u> funding in CAPE – Project 9007 to the new projects based on the attached spreadsheet. Schools may choose to transfer their expenditures and encumbrances in CAPE – Project 9007 to the appropriate institute's project or leave them in CAPE – Project 9007.

Information Systems and the Career & Technical Education Departments are working on the fiscal year 2013-2014 certification information for additional weighted FTE. Once this information is finalized, the Budgeting Department will allocate the new revenue to the appropriate projects.

Please keep in mind that the expenditures for any tests purchased by the Career & Technical Education Department will be transferred to the appropriate school institute's project. In addition, once the new revenue for fiscal year 2014-2015 is allocated, school institute projects will be used to pay bonuses for fiscal year 2013-2014 certifications earning additional weighted FTE.
