Career and Professional Education (CAPE) Allocation - FY 2014-2015

The Career and Professional Education (CAPE) allocation is a direct allocation to secondary schools based on students earning CAPE industry certifications. CAPE allocations are to be expended in the institutes earning the certifications.

Information Systems and the Career & Technical Education Department have provided the number of fiscal year 2013-2014 CAPE Certifications funded by the Department of Education. Finance has calculated each school's allocation based on this information and has credited your school's allocation to 1010-9890-0997-Center-Project. The CAPE projects are:

1. Weighted FTE Based on Certifications Earned in FY 2013-2014

The weighted FTE earned by each high school certification varied from 0.10 to 0.30. Middle school certifications were capped at 0.10 per student. The total weighted FTE earned by each school per institute for fiscal year 2013-2014 certifications is listed in this section.

2. Total CAPE Revenue Allocation for FY 2014-2015

The Weighted FTE in Section 1 was multiplied by the Base Student Allocation (\$4,031.77), District Cost Differential (0.9852), and 90% to determine each school's CAPE allocation. This amount was budgeted in 1010.9890.0997.Center.Project.
