SUBJECT:

Travel Reimbursement Rate Revision

The new mileage reimbursement rate for in-county and out-of-county travel incurred beginning January 1, 2022, will be based on the 2022 standard mileage rate issued by the Internal Revenue Service (IR-2021-251, December 17, 2021).

The mileage reimbursement rate for in-county and out-of-county travel beginning January 1, 2022, will be 58.5 cents per mile.

Any mileage incurred on January 1, 2022, and after should be submitted to the School District on the revised In-County or Out-of-County Travel Reimbursement Form labeled "Begin 1/1/22." Any travel incurred <u>prior</u> to January 1, 2022, should be submitted to the School District on the In-County or Out-of-County Travel Reimbursement Form labeled "Begin 1/1/21."
