SUBJECT:

Travel Reimbursement Rate Revision effective 7/01/2022

The new mileage reimbursement rate for in-county and out-of-county travel incurred beginning July 1, 2022, is based on an adjustment to the 2022 standard mileage rate issued by the Internal Revenue Service (IR-2022-124, June 9, 2022).

The mileage reimbursement rate for in-county and out-of-county travel beginning July 1, 2022, will be 62.5 cents per mile.

Any mileage incurred on July 1, 2022, and after should be submitted to the School District on the revised In-County or Out-of-County Travel Reimbursement Form labeled "Beginning 7/01/22." Any travel incurred <u>prior</u> to July 1, 2022, should be submitted to the School District on the In-County or Out-of-County Travel Reimbursement Form labeled "Beginning 1/01/22."
