MOBILE DEVICE RULES OF ACCEPTABLE USE

Mobile Device Rules of Acceptable Use:

1. Unless you have been directly told by the instructor to use your mobile device or applications on your mobile device for a classroom task, students agree not to:
 - a. Have their mobile device out or on (regular school/district policy applies)
 - b. Text
 - c. Make calls
 - d. Use mobile internet
 - e. Play games
 - f. Turn on blue tooth
 - g. Take pictures or video
 - h. Utilize any other applications not mentioned above
2. Students agree to abide by their mobile device plans (discussed with parents).
3. Students will not access mobile web.
4. On days that mobile devices are used in class, students will have their mobile devices out on their tables in full view.
5. School is not responsible for lost, damaged, or stolen mobile devices.

Rules specific to this school: No Internet – Just Cybernet

CONSEQUENCES:

1. The first time a student violates the **Mobile Device Rules of Acceptable Use** the student will lose privileges of participation in the classroom digital activities for one (1) week and write everything on paper. Their mobile device will be confiscated for the remainder of the class period by the teacher.
2. The second time a student violates the **Mobile Device Rules of Acceptable Use** they will lose privileges of participation in the classroom digital activities for two (2) weeks and write everything on paper. Their mobile device will also be taken away and turned into the office and standard consequence to that action will follow.
3. The third time a student violates the **Mobile Device Rules of Acceptable Use** they will lose the privilege of using the mobile device at school and will receive an office referral.
